1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Dumkal College was established on 21st September, 1999 by the order of the Government of West Bengal. It was NAAC (1st Cycle) accredited with B in 2016. It is affiliated to the University of Kalyani since its inception. It is a co-education college from its very beginning with all three streams - Arts, Science and Commerce. It offers a total of 17 courses including eleven Honours courses. The strength of permanent teaching faculty is 48 along with the Principal. Twelve permanent and five contractual non-teaching staff are the backbone of our institution.

Vision

The primary vision of the founders of the college was to reach the unreached corners of this minority dominated and agriculture-based backward border area of Murshidabad to cater to the higher needs of aspiring students, most of whom are first generation learners with the promise of education for one and all to enkindle the flame of wisdom and knowledge among the masses. The college envisioned to shape the learners of the institution into well-meaning citizens of the society through a socially committed, intellectually inclined and culturally motivated paradigm of learning. The motto of the college remains 'Igniting Minds, Empowering Future'.

Mission

The college with its avowed mission of bringing college education within the reach of common people will stride to become the vanguard of higher education in this socially, economically, culturally and educationally disadvantageous areas of the district. It will always try to provide quality education for all, to be alive to emerging needs and challenges, to emphasize value-based teaching, to empower the students to recognize and optimize their full potential. The college shall continue to uphold its vision and commitment to the society through a careful and systemic process of administrative decision making and academic activities. It will always strive to maintain a secular and democratic environment within the campus a sense of solidarity by providing conductive academic ambience for all classes of students and teachers. It will always make attempt to ensure to resist the flow of human trafficking, to reduce the migration of human labour and motivate the girl students to continue in higher students. To inculcate among the students, the need and process of research activities.

1.2 Strength, Weakness, Opportunity and Challenges(SWOC)

Institutional Strength

- 1. The College prides itself with a rich legacy of being the first-degree level college in the Domkal sub-division with three streams Science, Arts and Commerce.
- 2. Situated in a minority dominated area in Murshidabad, the college has significantly contributed to uplift the backward community through value-based education. Being a co-ed college, we are committed to the cause of

gender equity. The college also gives great importance to transparent functioning through financial audit, triple A audit, green audit, gender audit, Internal academic audit.

- 3. Most of the departments of the campus are connected with LAN and internet facility is provided for faculty members and students. Free Wi-Fi is also provided to the students in specified zones.
- 4. The college library has been automated with Online Library System through OLIBS software to facilitate all kinds of library related activities.
- 5. The college fosters a friendly teacher-student relationship to create a congenial academic ambience.
- 6. Departmental Laboratories are equipped with sufficient teaching aids.
- 7. Fully digital admission system is carried out. Merit lists are published online. The students can pay their tuition fees, examination fees, download their admit cards and results online. All kinds of notices are uploaded on the website and other accessible social media.
- 8. The NSS and NCC units of the college have been highly active with enthusiastic volunteers in taking initiatives like organizing blood donation camps, and other extension activities like rally on environmental protection, conservation of natural resources, awareness camp, etc.
- 9. The department of Physical Education, beyond its academic curriculum, remains very active in its direct and enthusiastic involvement in conducting Annual Sports and other activities of the college. Most of the cadres of the NCC unit are chosen from this department.
- 10. The campus is well covered under CCTV surveillance.
- 11. As the college is situated in a rural setting, it offers a distraction-free atmosphere on green campus conducive for academic pursuits.
- 12. The college boasts of a clean and eco-friendly campus with regular plantation drives etc.
- 13. 15 MoUs and linkages are signed with other higher educational institutions for faculty exchange and students' enrichment.

Institutional Weakness

- 1) Lack of sufficient classrooms and working space especially for laboratory-oriented subjects. Shortage of faculty members in all subjects of science and arts stream. Considering the fact that the Government is not sanctioning sufficient permanent posts, it is a challenge for the administration for academic management.
- 2) Shortage of technically skilled non-teaching faculty members due to delay of government recruitment process. Most of the laboratory-based departments lack technically skilled lab attendants.
- 3) As the college is heavily dependent on government funding, non-availability of any type of financial support (both government and private) for construction of new classrooms, repairing damaged instruments and maintenance of the existing equipment, digitalization of library, infrastructure development, research and other

academic activities are done with own funds.

- 4) Constrained with low fee structure.
- 5) To continue the programmes where the enrolment of the students is far below the sanctioned limit e.g. in Commerce.
- 6) Most of the students admitted to this institution belong to Bengali medium background. The greatest challenge for this institution is to impart knowledge in English to these students.
- 7) The college does not have its own playground. Therefore, we have to use adjacent playground.
- 8) Lack of a Boys' Hostel and the incompletely constructed Girls' Hostel, because of lack of funds leads to inconvenience for out-station students.
- 9) There is a hindrance to cater for the specific needs of the 1st generation students in comparison to the advanced students of the city-based college under the same university.
- 10) The most unavoidable hurdle for the students to attend the classes regularly is the distance of the nearest bus stop from the college (almost four kms) and the extra financial burden to avail the local transporting system of private vehicles. This also severely affects the number of admission and attendance of students in the college.
- 11)The college lacks a hygienic canteen of its own with minimum facilities both for the staff and the students.
- 12) Due to financial constraint, the college does not own a gymnasium or a large auditorium.
- 13)Required facilities for the differently-abled students are not sufficient.

Institutional Opportunity

- 1) The college offers various courses and subject—combination from Arts, Commerce and Science streams to ensure horizontal flexibility in selection of course curriculum. This has become very effective with the implementation of CBCS syllabus in all programmes since 2018-2019. It paves the way for the implementation of National Education Policy 2020.
- 2) The college has introduced several courses on soft-skill developments in different departments to meet the new learning demands of the era.
- 3) There is a scope for the introduction to new-generation courses like Digital Marketing, Data Science, Rural Health Care and Graphic Design, etc.
- 4) There is incentive for financial help for the economically backward students by providing them several scholarship programmes of government as well as through "Half Free" scheme implemented by the administrative body of the college.
- 5) There is scope for institutional journals with ISSN and college publications with ISBN.

- 6) The institution has already signed a number of MOUs with colleges in the adjacent areas which we could explore more such collaborations with colleges in other parts of the state or even other states.
- 7) There is scope for better service to the students if we get a new building which would also include classrooms, language labs, gymnasium and a well-maintained auditorium. There is further scope for other infrastructural developments under RUSA.
- 8) When the Alumni Association will function with full potential, the successful and established alumnus would inspire and guide current students.
- 9) The college has study centres of NSOU, IGNOU for higher studies and also a study centre of the Distance Education Directorate, the University of Kalyani which is a great educational opportunity for this backward area.

Institutional Challenge

- 1) Lack of funds from governmental and other non-governmental bodies for infrastructural development and for research-extension programmes.
- 2) A large portion of the college fund is used for salary of the casual staff and maintenance of present infrastructure leaving less funds for utilizing in development purpose.
- 3) The problem of growing unemployment discourages the students to continue in the higher education, especially in such an area where the number of school drop-outs is alarming and the tendency to migrate to other states for earning alms in a very young age is also a serious cause of academic concern.
- 4) Since the recruitment of both faculty and non-teaching staff is dependent on the State Government, the college lacks sufficient number of teaching and non-teaching staff. At such times getting administrative work done or finishing academic tasks is a real challenge.
- 5) Constructive participation of the Alumni Association is not up to the mark.
- 6) Motivating students to use smartphones for academic purpose.
- 7) Lack of interest for competitive examinations among most of the students.
- 8) Lack of basic communication skills, especially in English, among the students, who are mainly from rural areas.
- 9) Because of its location, students have rarely any exposure to the real-life working experience or other comparatively metropolitan advantages.
- 10) Another challenge is to motivate the students for self-employment, and entrepreneurship in order to enhance their future prospects.

- 11) Lack of sufficient nearby industries for placement and internship.
- 12) The distance from main road and the transportation cost thereof severely affects the number of admission of students and the regularity in their attendance.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

Dumkal College follows the curriculum designed by the University of Kalyani. The college has designed several add-on courses (17) during the last five years.

Academic Calendar: The academic activities of the college is regulated by the academic calendar, prepared at the onset of the session, in compliance with the academic schedule and directives issued by the parent University.

Admission Process: The admission process is conducted through online mode with transparency, adhering to WB department of Higher Education guidelines ensuring reservation policy for SC/ST/OBC students. Merit lists are published online. Fully digital admission system is carried out.

Commencement of academic session: Every new session commences through induction meeting with the freshers, so that they feel comfortable and confident. The class schedule, both departmental and institutional are provided to the students on that day. Library Orientation programme is also conducted regularly.

Digital student support system: All kinds of notices are uploaded on the website and other accessible social media. The students can pay their tuition fees, examination fees, download their admit cards and results online. Our college library has been digitally automated. The library has a study room for students and a research room for teachers, where they can avail desktop computers for study/research. The college campus has internet facility with free Wi-Fi. There are two smart classrooms, a seminar room with projection facility. Feedback from students (SSS) are taken online at regular intervals to ensure valuable input for the teachers.

Role of IQAC: The IQAC always monitors the whole academic process systematically striving to enrich the teaching-learning processes.

Cultural and Social Activities: The college organizes quiz-competitions, annual cultural functions etc. beyond the syllabus. The NSS and NCC units are highly active in taking initiatives like organizing blood donation camps, and other extension activities like rally on environmental protection, conservation of natural resources, awareness camp, etc.

Cross-cutting issues: Undergraduate Syllabi of the subjects taught inherently have cross-cutting issues of gender, environmental sustainability, professional ethics, human rights and values for sensitizing students with a healthy educational environment.

Teaching-learning and Evaluation

Continuous evaluation: The academic calendar incorporates a continuous schedule of internal assessment,

submission of assignments, practical and project works etc. along with the term-end university examinations.

Feedback: Regular feedback is collected from students through structured feedback form following the UGC guidelines which is worked upon by the IQAC. The progress and the challenges identified determine subsequent plannings undertaken by the IQAC.

Platforms of social media: With a seamless transition from conventional to online teaching-learning, the college offers various digital platforms and social media for sharing important information and study materials for the students.

Student-Teacher Relation: The college fosters a friendly teacher-student relationship to create a congenial academic ambience.

Academic Excellence: The well-planned lesson plans in keeping within the time-frame of the academic calendar, necessity-based tutorial classes result in the effective academic excellence of the students.

ICT facilities and laboratories: This college has three ICT enabled classrooms and two of these are equipped with smart board. The college has a seminar hall, with sufficient digital facilities. All the laboratories of the departments of science are user friendly, well equipped with necessary instruments and software to facilitate practical teaching learning. The computer laboratory has 32 desktops and the laboratory of the department of Mathematics and Geography have 10 and 14 desktops respectively. The Chemistry laboratory has 03 desktops and the laboratory of the department of Physics has 02 computers for the use of faculty and students.

Library Resource: Our college library has been automated since 2015 with Online Library System through OLIBS software. It contains a collection of 13225 books (as of 2022-2023 session). The following services are provided in the library: 1. Home issue facilities 2. Reading room facilities 3. Success Rate: Maintaining a constant success rate of over 90%, the College testifies to its commitment for its students' education and welfare.

Research, Innovations and Extension

Research and Innovations: The college has a Research and Publication Committee to foster innovative ideas and a conducive environment for research. The IQAC and college administration also foster a research culture within college. It always encourages the faculty and the students to publish research articles, books and chapter in monographs and books. Some of the faculty members, who did not have PhD, were inspired to pursue their doctoral degree in their respective subjects. Our faculties have marked their contribution in 37 peer reviewed journals, and some of them are enlisted in UGC Care list, and 38 Books / Book Chapters / Seminar Proceedings. The college conducted more than 37 seminars and workshops. Our college library is rich with a collection of 13225 books (as of 2022-2023 session). It has subscribed for INFLIBNET NLIST to offer e-journals and e-books for the staff and the students for further study. It has separate research room with computer and internet facilities to carry on their research work. All the laboratories of the departments of science are user friendly, well equipped with necessary instruments and software to facilitate any kind of research work.

Extensions: Dumkal college has always endorsed the value-based social activities for inculcating the sense of social responsibility among the students. Our college has shown commendable support to the neighbouring community during the pandemic, providing every possible assistance like distribution of oxygen cylinders, masks and sanitizers etc. The regular departments of our college have organized 52 seminars, workshops, rallies on a wide range of topics as extension activities. Additionally, the units of National Service Scheme (NSS) and National Cadet Corps (NCC) of our college have organized 22 camps, outreach and awareness programmes in the last five years of assessment such as Blood Donations, Cleanliness Campaigns, Environmental Awareness Campaigns, Health and Hygiene related activities etc. NSS has adopted Basantapur, the nearby village where the volunteers visit frequently to sensitize the people there regarding the aforementioned issues. The Electoral Literacy Club (ELC) of this College has undertaken several innovative programmes and initiatives to promote electoral literacy and civic engagement. The Constitution Day and the National Voters Day were celebrated with due emphasis.

Student Support and Progression

Our college supports students in their academic as well as co-curricular activities, aiming their overall development. The college serves students from all segments of society and adheres to the State Government's admissions policy regarding reservation for ST, SC, OBCA, OBCB and differently abled students. The college is situated in a rural area and has earned an excellent reputation and goodwill from the surrounding community; enrollment of student is satisfactory. The pass percentage of outgoing students is high during the last five years with a significant number of first classes each year. Scholarships are provided by State Government, Central Government, and nongovernment organizations to eligible students. Under the 'Kanya Shree Prakalpa' of the Government of West Bengal, female students up to the age of 18 are given onetime support. Eligible students from the minority community are entitled to get scholarship under the scheme of 'Aikyashree' from the Government of. West Bengal. A number of departments publish wall magazine giving the opportunities to the students for developing their writing skills. Many departments conduct several add-on courses to facilitate students with opportunities for enhancing their skill set, increasing their employability, providing flexibility in their academic schedule, and allowing for personal growth and exploration of new interests. Games and sporting events and competitions are held annually at the interclass level. Some qualified students are selected for participating in the university level competitions. The college organizes various cultural events where intracollege competitions on co/extracurricular activities such as music, debate, and quizzes. In addition, the involvement of students in the Youth Parliament under the supervision of competent teachers contributes to the development of their personalities.

Governance, Leadership and Management

Though Dumkal College is located in a backward border minority dominated area with limited infrastructural facilities, we have always been endeavouring to overcome the deficiencies with active dedication to and positive enthusiasm for its betterment. With experienced and dedicated teachers, our college helps students realize their goals in life. The administration of the college is elemented through sound governance, competent leadership and able management to support the academic activities. 	designed by the parent university. Although the college has a limited scope for framing the curriculum some of the faculty members are engaged as members of the Board of Studies and actively participate in the meetings, workshops for development of revised curricula Dumkal College plans to organize conferences and seminars with the science and humanities faculties with a view to expanding the horizons of knowledge for students. Important days like International Yoga Day, Environment Day, are to be celebrated and observed bringing together all the disciplines of the college. The college has active NSS and NCC units. Blood Donation Camp of the institute is organised jointly by the NCC and NSS units of our college. The University has made it compulsory to study "Environmental studies" in their regular curriculum as a part of multidisciplinary education. As part of the process for the introduction of Credit Based Four Year Degree Courses under NEP 2020 the college has offered 12 Major and 14 Minor subjects from the session 2023-2024 to its students and also introduced multiple entry and exit options at different stages as framed by the parent University. In the new system emphasis has also been given on seminars, workshops, field visits, study tours etc. to enrich the curriculum.
2. Academic bank of credits (ABC):	The college has successfully implemented the process of ABC in the college as per the guidelines (CoE/ABC-ID/3/UG/2023 dated 08.05.23) of the University of Kalyani. All the students are directed to register and submit the ABC ID to the College, which is a obligatory requirement for getting university registration
3. Skill development:	The Choice Based Credit System (CBCS) introduced by University of Kalyani mandates Skill Enhancement Courses (SEC) for all disciplines. So, they are already open to various skill development courses. Moreover, there are courses which cover Soft Skills, Computers, Elementary Mathematics, Communicative English etc. where all students are given exposure to Skills relevant for future. Different multidisciplinary courses (MDC), Value-added will be introduced from 2023-2024 following NEP-2020 guidelines.
4. Appropriate integration of Indian Knowledge	The college percolates the Indian Knowledge System

system (teaching in Indian Language, culture, using online course):

and cultural system by teaching ancient Indian texts in the departments of Sanskrit and English as reflected in the syllabi of these departments. Besides, the department of Philosophy teaches Indian philosophies to its students. All the subjects are taught in bilingual mode i.e. English and Bengali. Beside this, the NCC and NSS units of the college are actively promoting ethical and social human values, and also life-skills etc. The college plans to introduce a certificate course on value education run in online mode through which the students can imbibe Indian Value system. International Mother Language Day is celebrated in the college on 21st February every year. The birth anniversary of Rabindranath Tagore is observed every year. The legacy of reciprocal 'Gurushishya Parampara' is symbolically maintained through the celebration of the Teachers' Day on 5th September every year.

5. Focus on Outcome based education (OBE):

Under the NEP 2020, the college plans to strengthen the already existing system of student-centric teaching-learning approach. The institution organizes both centralized and department-specific orientation programmes for newly admitted students to assist them in grasping the goals and objectives of their specific programmes and courses. Even the Programme results, programme-specific outcomes, and course outcomes of all courses have been posted on our college website for our students' advantage. Every department also gives emphasis on the continuous systematic analysis of the performances of students through the following measures: Semester Term-end examinations; two Internal Assessment, Class performance activities like projects, assignments, presentations (in the department of English).

6. Distance education/online education:

Situation during the COVID pandemic situation already taught us the value of using online digital platforms like Google Meet, WhatsApp groups in disseminating knowledge through digital learning materials, taking online classes, evaluating answer scripts and uploading marks online etc. As internet-connected smart phones or tablets are available to almost all the students the process of teaching – learning online becomes much easier and effective. We have already two smart classrooms a Seminar Room with projection facility where digital pedagogy is used enriching the teaching-learning process.

Feedback from students online at regular intervals ensures valuable input for the faculty to evaluate and restructure their own teaching methods for better efficacy. Technology based teaching methods adds efficiency and transparency to the existing lecture-oriented tradition. Our Library is already digitized and steps are being taken to enhance online accessibility of library books from the digital libraries of other institutions also. The college already boasts of Open Distance Learning (ODL) through the study centres of Netaji Subhas Open University (NSOU) and Indira Gandhi National Open University (IGNOU) to provide opportunities for life-long learning for the mass

Title of the Practice: Rain Water Conservation

Objectives of the Practice:

The Practice:

The college has an active Campus Development and Beautification Sub-Committee that follows an environmental policy to maintain cleanliness and hygiene on the campus and to make the campus ecologically sustainable.

The college arranged a programme titled 'Save water to save life on the Earth' in collaboration with the department of chemistry.

Though rainy season is short here in the Dumkal subdivision, still we judiciously utilise the rain water.

The college has undertaken an environmental audit for making the campus more environmentally sensitive and sustainable.

Evidence of Success:

The college, especially the department of Chemistry has been able to conserve considerable amount of water.

During rainy season student use rain water for laboratory work.

Problems Encountered and Resources Required:

In the beginning, there was considerable debate about the long-term credibility of the rooftop water collecting system from rainwater. It was pointed out that the main problem would be the annual maintenance costs and lack of trained personnel for maintaining the system, but this initiative has proved to be a great success. With additional funding, we can extend this benefit to all departments in this college.

BEST PRACTICE-II

Title of the Practice: Implementation of Online Digital Management System in all spheres of Academic and Administrative activities

Objectives of the Practice:

- To enhance awareness of the students regarding the facilities of digital platforms.
- To expedite administrative tasks.
- To ensure that the virtual environment is accessible to all students and faculty, regardless of their location.

The Context:

- The smooth functioning of the college in teaching learning as well as in the administrative activities significantly affected by the poor network connectivity.
- The imbalance in the ratio of teaching and non-teaching staff and also the teacher student ratio creates a serious practical problem to impart quality teaching learning experience to the students without the aid of digital facilities in teaching learning process.
- As the world is rapidly embracing AI, it is imperative to upgrade our IT infrastructure to provide a holistic high-education experience to our students.
- Besides time management economy, also to reduce the cost of the daily operations, the adoptations of the digital systems becomes the demand of the day.

The Practice:

- The admission process, marksheet distribution, scholarship distribution, payments, and other related activities are operated online, which is also mobile-friendly.
- The central library has a sufficient number of textbooks and has been partially automated since 2015 with the Online Library System (OLIBS) 2.2 software. Free dedicated Wi-Fi is available for students and staff at the library.
- The college has three ICT-enabled classrooms with projector facilities, and two of these are equipped with Smart Boards. ICT facilities such as Wi-Fi and internet are available in the seminar hall.
- Google Meet, Google Classrooms, and other digital platforms are used by all departments of the college for teaching and learning actively.
- The departmental WhatsApp groups, the official Facebook page, Bulk SMS, and other related media are used to communicate with students and staff online.
- As of 2023, admission forms, notices and merit lists of the students are managed online.
- HRMS was instrumental in the management of salary and provident fund of the staff.
- Internal accounts are maintained using Tally ERP 9 software.
- Salary of teaching and non-teaching staff is transferred directly to their respective bank account. Salary bills are submitted to the treasury through IFMS software.
- Departments provided study materials through WhatsApp groups, Google Classrooms and also the college website.

The Evidence of Success:

- To ensure minimum time for book handling and accessing the books, they are bar-coded. OLIBS ensures internet browsing and online public access catalogue service. INFLIBNET and N-List allow access to E-Journals and E-books. Students can check book availability from their mobile devices also.
- Computerization has been implemented throughout the office, including the principal's office. Ebilling and WBIFMS are used for financial transactions.
- Since 2016-17, the admission process has been conducted entirely online.

Problems Encountered and Resources Required:

- The college has been continuously making efforts to update its IT facilities, including Wi-Fi, and is gearing up its IT infrastructure for AI.
- We are in need of more financial resources and technical staff.

Response:

The primary vision of the founders of the college was to reach the unreached corners of this minority dominated and agriculture-based backward border area of Murshidabad to cater to the higher needs of aspiring students, most of whom are first generation learners with the promise of education for one and all to enkindle the flame of wisdom and knowledge among the masses. The college, since its inception became a hub of higher education for the girls of the locality. Keeping in mind the vision stated above, the college authority has prioritized women's education in this minority dominated backward areas of Dumkal subdivision in Murshidabad district. Initially, the college had to face unique challenges due to cultural diversities, socioeconomic disparities and lack of resources; though, the college has overcome these obstackles and played a crucial role in empowering women and promoting gender. Some potential indicators of success can be noted below: a) Ours is the only institution in the sub-division to offer the opportunity to study Honours in science subjects like Physics, Mathematics, Chemistry, Geography and Computer Science. So, it has been a unique opportunity, especially for women, to realize their dream to go for higher studies in science. The male-female ratio in the science stream (approximately 70:30) is a testimony of our success in attracting the girls for higher study in science. The rate of retention and completion of studies by the women students is encouraging and satisfactory. b) The women students, along with other minority students can access the resources provided by the government and the same being facilitated by the college to support women's education, such as different scholarships, mentoring programmes, and counselling services etc. c) The success of female graduates in finding employment or pursuing further education after completing their studies, are considerably high. d) Moreover, ours is the only institution in the sub-division to have the study centres of both Indira Gandhi National Open University (IGNOU) and Netaji Subhas Open University (NSOU) and the distance education system or DODL of the parent university. They aim to provide quality higher education opportunities to all segments of society. It also aims to encourage and strengthen the human resources of unprivileged areas through education. Its motto is to impart accessible and inclusive education to a diverse range of learners, regardless of their age, background or location. Therefore, these study centers have enabled the women of the locality in particular to pursue higher education and achieve their academic and professional goals. e) Due to online admission system students from other districts also came to study in this college particularly in science related subjects.
