
Topics for the second internal test are given below:

PHIL-H-CC-T-13	a) Discuss John Hospers' views on the use of the verb 'know', examining his analysis of the conditions for knowledge Or , b) Discuss John Hospers' views on the criteria of sentence-meaning.
PHIL-H-CC-T-14	a) Discuss Aristotle's concept of universals, highlighting how he differs from Plato in his views on the nature and existence of universals. Or , b) Analyze the tensions between determinism and free will, and evaluate the implications of determinism for moral responsibility and human agency in Western philosophical thought.
PHIL-H-DSE-T-03	a) Explain the core principles of Deep Ecology and its significance in environmental ethics. Or , b) Explain the importance of trust and communication in doctor-patient relationships.
PHIL-H-DSE-T-04 & PHIL-G-DSE-T-2B	a) Analyze Swami Vivekananda's ideology of Karma Yoga. Or , b) Examine the key principles of M.N. Roy's Radical Humanism and discussing its philosophical foundations.
PHIL-G-SEC-T-4	a) Analyze the concept of the three gunas (sattva, rajas, and tamas) in Yoga Philosophy, discussing their influence on human behavior and the path to liberation. Or , b) Discuss the role of meditation (Dhyana) in Yoga Philosophy, highlighting its benefits for mental clarity, emotional balance, and spiritual growth.
PHIL-G-GE-T-02	a) Analyze the concept of probability in inductive logic, discussing different interpretations of probability Or , b) The Method of Joint Method of Agreement and Difference: A Critical Analysis of Its Application and Limitations.
